See attached instructions for more detail. **Applications lacking any of these items will be returned unprocessed.**

The maximum time for processing a completed application is 90 days. If the Department fails to meet the time period for the processing of a certificate, the applicant, within 30 days of the final decision granting or denying the application, may apply in writing for a full reimbursement of any fees. The Department shall respond within 14 working days of receipt of a request for reimbursement; and if the reimbursement is denied by the Department, the applicant may directly appeal the denial in writing, to the Attorney General.

I declare under penalty of perjury (Sections 126 and 672 PC) that all statements made by me on this application are true and complete. I understand the Department of Justice has no responsibility for insurance coverage for myself, my instructor(s), my students, my classes, or my course(s) on handgun training, use, and safety. I understand all publicly disclosable information submitted by me for recognition as an entity providing comparable firearms safety training to those entities listed by Penal Code section 12804(j) is a matter of public record. I understand that I must renew my application for recognition as a comparable training entity in five years. I understand DOJ's recognition can be revoked for cause.

Instructions for Completing Application for Department of Justice Recognition of Comparable Entity in Firearms Safety Instruction

Instructor Qualifications

A DOJ Certified Instructor Card number must be provided on the application for each proposed instructor. For each proposed instructor, the application must be accompanied by a resume/statement indicating a minimum of 100 hours verifiable experience teaching/training firearms safety. The resume/statement must include contact information for experience verification.

Course Outline, Syllabus, or Text

The application must be accompanied by a course outline, syllabus, or text which, at a minimum, must include the following:

- 1. Instruction on Safe Handling Demonstration Steps for the following conventional handgun types:
 - Semiautomatic pistol, Double action revolver Single action revolver
- 2. Instruction on Safe Handling Demonstration Steps for the following handguns with alternative designs:
 - Semiautomatic pistol with a non-locking slide Semiautomatic pistol with a fixed magazine Semiautomatic pistol with a magazine-operated toggle lock Semiautomatic pistol with a top-feeding magazine Semiautomatic pistol with a tip-up barrel Break-top revolver Single shot pistol Derringer
- 3. Instruction on how to render a handgun safe in the event of a jam (malfunction).
- Requirement for all students to successfully perform the Safe Handling Demonstration with the three conventional handgun types (Semiautomatic, Double Action Revolver, Single Action Revolver). The handguns used for the demonstration must be provided by the DOJ Recognized Safety Instructor.
 - **Note:** Minimum course content required by DOJ (1- 4 above) must be presented by a DOJ Recognized Safety Instructor only. Any additional instruction that exceeds or is unrelated to the DOJ required content need not be presented by the DOJ Recognized Safety Instructor.

Certificate of Completion

Upon successful completion of the training course, DOJ Recognized Safety Instructors shall issue a Certificate of Completion to each student. The Certificate must include the name of the training course, students name, signature of DOJ Recognized Safety Instructor, and date.

The application must be accompanied by a sample of the proposed entity's Certificate of Completion.
