This is a formal request to your office for a title and summary of the attached proposed initiative. which is supported by CAMPAIGN FOR MENTAL HEALTH, A PROGRAM OF THE CALIFORNIA COUNCIL OF COMMUNITY MENTAL HEALTH, AGENCIES, a recipient committee – ID # 1254533.

It is our intention to place the proposed initiative before California voters for the November 2004 General Election.

This proposed initiative, among other actions, would:

- Expand mental health treatment options for children, adults and seniors;
- Expand programs to prevent mental illness:
- Create the Mental Health Services Oversight and Accountability Board, comprised of elected officials and Governor appointees, to oversee the initiative
- Provide for expansion of treatment capacity both human resource and facility.

This initiative modeled on AB 34 (Steinberg) of 1999 and is expected to achieve comparable cost savings.
